- Accurate data entry! How do you get accurate data entry?
- Attorneys use the case management system for entering charging decisions and court activity, especially dispositions and sentencing
- Without timely Charging and Disposing – Workload tools don't work
- Support staff should not retype what an Attorney decided or heard in court

Once you have accurate data entry, you can...

- Use case management to assist the assignment of cases
- Use case management to monitor work queues
- Use case management for internal dashboards
- Use case management for external dashboards




